V4 Regional Chamber-to-Chamber Meeting 1.0 “C2C”

Background

On 6 September 2016, an international conference was organised by the Chamber of Commerce and Industry of Pest County and Érd City with County Status with the participation of regional chambers from the V4 countries.

The conference as the prelude of the project lead to the realization that the regional chambers of commerce and industry already have a strong potential but there is always room for development.

It was proved that chambers can achieve positive results mostly on a regional level, thus the cooperation and harmonization of activities of the chambers of commerce and industry would be most beneficial at



The Project

Public events held within the framework of the project will be the next step of the cooperation process launched at the conference in September 2016.

The representatives of the participant chambers and invited experts from the V4 region will discuss in a *round-table discussion* on the most recent challenges of the dual education issues in the V4 countries. The round-table members will examine how the co-operation will contribute the competitiveness of the V4 region.

The publicity will have opportunity to ask the round-table speakers in a *forum talk* about the dual education, professional training and about other relevant topics which are the most acute.

Parallel the forum and the round-table talk and beyond some Hungarian, Slovak and Czech *enterprises will introduce* their products and services in the area of 37th Rye Island Fair between 21st and 24th September 2017 in Dunajská Streda.

Participants

Participants chambers have set the goals of the project as to facilitate long-term operative co-operation between regional chambers of commerce and industry (CCIs) through regular meetings and common actions.

The implementation of the project events should be an example and model for a series of annual joint events where other CCIs will have opportunity to meet in other regions of the V4 countries. Strategies and joint actions developed at the meetings can synergistically improve the competitiveness of the V4 area both on a global and on EU level.
